
To use this USB, you will need to own a computer which is running windows 10 or higher with

The supplied USB should automatically load up, unless you have disabled the autoruns option within Windows.

If the loader/disclaimer screen asking for Google Chrome Updater, fails to be displayed, then you will need to run the either the files named **DisClamerAndLoader.exe** or **RunMe\_First.exe**

The Following Screen, Will Only Appear, If Google Chrome Portable Has Already Been Installed Onto The USB.

If It Doesn't It Will Go Straight To The Disclaimer Screen On Page 3.



**The Following Screen, will only be displayed once !!!!**

This is because, the supplied USB stick, has already got a Pre-installed Portable version of Google Chrome.


Every time the portable version of Google Chrome is loaded, it will ask you to update/re-install

**!!!! In this case, just click onto the close icon, and continue working !!!!**


If your already have the full version of Google Chrome installed on your computer, you must select the 'No' option.



The disclaimer screen will then be displayed as below.




Once this screen has appeared, you can either quit, by clicking on the close button located in the top right corner or you can click on the Display disclaimer and agree button.


If you have decided to continue you will see the following screen.




**The decision is yours.**


## Choosing option (2) – Drop Down Menu Navigation.

Please note, to use any of the associated linking/links within these documents, you must map the USB stick as drive 'R:\'. This can be achieved by running the "RunMe\_First.exe" file which is held on the USB first. Alternatively, you can open a COMMAND LINE (dos prompt) and type:-

**subst R:\ USB STICKS – DRIVE NAME:\**

This program will create a mapped drive called R: and this will allow any linking, links within any of the provided documents to function.
