This program has been created using a name only for the purpose of reference and it has not and will not be advertised for commercial use. It's only purpose for it being created was so that the author and the authors legal team can manage his/her legal appeal case against his/her sentencing and conviction. The program's sole purpose and design helps the author to be informed of the progression of his case without having to face 2 face lengthy legal meeting's.

This program has only been created for the sole purpose for the management of the authors legal appeal case against his/her sentencing and conviction.

Please note, the use of this USB, which includes all of the authors software and all of his legal paperwork, is only to be used by an authorised legal representative for the management of the author's legal appeal case.

Please also note, the responsibility of the use of this USB/disk, rests with the end-user, which includes the use of the software and the data. Any lose of data or damage caused by it's use rests solely with the end-user.

Use At Your Own Risk !!!!

LeagueLoch v1.3r8. has been programmed to run from the USB drive only. Although, the data held on this disk can be manually backed up to your hard-drive. This program was originally written to be used as a stand-alone program and only for the purpose of the authors Legal Appeal. LeagueLoch, will start-up in MODIFY mode.

The authors assigned Solicitor has no obligation to use this software, it's only purpose is for the author to track/manage the progress of his/her own Legal Appeal.

He/she will be regularly phoning the Solicitor and asking for updates/progress, so that he/she can log the response !!!!

You will be supplied with 1 authorisation code per disk, any additional disks will be issued with a different authorisation code. This authorisation code has been deliberately created to be more complex due to the fact that it is a combined username/password !!!!

The original LeagueLoch program was going to be multi-user, but the author decided that it was only to be used on his/her appeal case and to only be associated with his/her own USB's.

The authorisation code can be shared and used by the assigned legal team only, that's been assigned to over look the authors Legal Appeal Case.

Once LeagueLoch v1.3r8 , has loaded, you will be greeted with the following login screen.



Firstly, you will need the supplied authorisation code, which is normally located on the last page of the instruction manual.

Once you have entered the authorisation code, you must click onto the authorisation Button and then you will be taken to the main screen.

From the main screen you have, the clients field (the name of the client), view clients contact details (button), clients ref (this has already been set for the authors reference, although, in modify mode this can be changed), open/closed record (closing the record once your finished with working on it !!!!), title/description of the file you want to attach, filename/file-path (is selected from the attach button, this is only required if a new record is to be added or the original file has changed), file type (document,video and dummy. Record type !!!!), File notes yes/no (putting a yes into this field, saves all notes typed into the case notes field, a no will result in the notes not being saved.)

The records list selection box, clicking onto the desired record once will load, the description/summary of that Record and by double clicking onto that record will load, the physical file.

You can also edit the record summary using an external word processor, either with your own favourite word processor, or by using the default editor, LeagueEdit. You can change this by just right clicking onto the LeagueEdit button and change the editor !!!!

LeagueEdit.exe (Leahueloch's Casenotes Editor).

Please note, when you are using an external text editor, you must use the save option within the text editor to save the changes. After you have finished and have closed the text editor you will see a message asking you to click the (ok) button. This will inform LeagueLoch that you are finished and then it will update the database !!!!

When using LeagueEdit, it's been programmed to automatically update LeagueLoch's database. Just by clicking on to the save/exit button. You can also edit/cross reference multiple records by using LeagueEdit.

New Records button, this adds a new record. Make sure that all of the fields have been filled !!!!

Modify records button, modifies all of the fields, excepting the records title field. You need to be in Admin mode.

(Or, you can just Delete the existing record and then create a New record !!!!)

Delete Records button, only ear-marks the record as deleted, its not actually deleted !!!!

Show Background (button, loads up the default file name :-

Please note that all of the records listed from this screen are shown in creation order (default), which will include, all open/all closed and all deleted records.

To change the listing type and to sort in alphabetical order, you will need to right click onto the List all (open/closed) Records !!!! heading label. This will be explained later on in the Operation's Manual.

You can also use to up and down cursor keys, to scroll up and down the records list. This will automatically load and display the records summary !!!!

To add a reminder to the selected record, select the time and date you wish to be reminded and then click onto the Add Reminder (button).

If you wish not to add a reminder, but wish to leave, just click onto the exit (button).

If there is an existing reminder for that selected record, the add screen will change to a reschedule screen. On this screen you can either re-schedule it or you can close it. If you wish to leave without changing the existing reminder, just click onto the exit (button).

When you are typing in your reminder comments, it will automatically check your spelling !!!! Any miss pelt words, they will be highlighted by a red squiggly line and to correct the spelling just simply right click !!!!

Please note that adding a reminder to a record will only add that record to the reminders list. It will not automatically display it on start up.

On a daily basis you will need to check your own reminders list and manage it from there !!!! LeagueLoch was only created for the end-user to manage the authors Legal Appeal case from the supplied USB /DVD !!!!

It wasn't created for a multi-user environment using a shared drive. !!!!

Please note that the reminder list(s) isn't a replacement for the end-users self reminding mechanism's, such as Windows sticky notes or the good old fashion post-it notes.

The LeagueLoch's reminder list(s) has been only designed so that the end-user can be reminded to finished off any vital record summary updates, such as evidence references/ document links etc.

The author's favourite word processor is Microsoft's Word. He hasn't written this editor to replace such an iconic and brilliant program.

If you have decided to use your own favourite word processors, such as Microsoft Word or Wordpad. Please be aware that editing the records summary will only take effect once you have saved your work by using the save button only.

LeagueLoch's database will not be automatically refreshed and will need you to manually reload that record.

LeagueLoch's Text Editor has an insert link command which is same as LeagueLoch's. This option is different to that of other word processors.

For example, if a complex link is inserted into LeagueLoch, such as YourDocument.pdf#page=5.

The page jumping parameter, will trigger LeagueLoch in to creating a HTML file.

When the link is clicked on, LeagueLoch, creates a HTML file called LeagueLoch_Temp.Html, which in turn allows LeagueLoch to load the desired document, (PDF's, with Page selection), as a HTML Link.

This option has been especially programmed to allow any complex links to be able to work in all PDF file Viewing programs such as web browser etc.

This HTML file can be easily copied or renamed.

The filename is called, LeagueLoch_Temp.Html.

This file can then be used for in document linkage etc.

You can also Read Aloud, the whole document by clicking onto the Read Aloud button, or you can just read out the text that you have selected.

This can be done by selecting the Read Selected option from the pop up menu.

Once you have clicked onto the Read Aloud button you will see the above screen.

It will display the record summary of the selected record.

You can click onto the Read Aloud button, which will then read all of the records summary.

You can also select the text that you want to hear by selecting the text and then right clicking, which will take you to a pop up menu with the option of Read Selection.

The Read Aloud facility is also available within LeagueEdit text editor, making it easy to hear what you have typed before saving !!!!

*** Please note, using this facility will use lots of computer resources and may slow down your computer. ***

**** Please also note that holding down the ctrl+shift+u key will allow you to Read Aloud HTML & PDF files in Microsot's Edge, Web Browser ****

**** Please also note that Windows 10 has a built in Read Aloud utility within the Magnifer program. To run it, just press and hold the Windows Logo Key + Plus (+) buttons. **** The I/O 131 error, normally occurs when either Windows is throwing a wobbly or the user hasn't configured the controlled folder access for that app.

To configure Windows controlled folder access, you must first go into the settings and select updates and Security.

Then you must select Windows security, after which you must select the Virus & threat protection option. You then go into the Virus & threat protection settings, which is labelled, manage settings.

Once you have select this option, you may need to scroll down to the option called controlled folder access and then click onto the option manage controlled folder access.

From here, you can see the option to allow an app through controlled folder access.

Once you have clicked onto this option it will display a window asking you if you want to add an app to the controlled folder access !!!!

Selecting yes, will give you the options to add an app. Selecting a no, will obviously terminate that option.



Once you selected and have double clicked onto a record in LeagueLoch, you will see the above screen !!!!

You will notice from the above screen shot, there's two tabs being shown.

This is because the user has decided to open the link thats highlighted in pink, into a new tab.

In this example, the pink worded area in this document, is a in document link.

Please note, the in document link, can be of any colour, and the user will only notice that its a in document link by the changing of their mouse pointer when they are on a link.

This link could have easily been opened in the same tab, by just clicking directly onto this link, but this action, will only display the new links contents of the new document.

Instead of left clicking, right clicking onto this link and selecting from the popup menu, open link in a new tab, this will create another tab, which will then display the new document.

Notice that, the second tab is greyed out, this is because it's not in focus state.

You can tile both tabs, by simply holding down the control key, and then clicking onto both the tabs individually which will select them both.

Please see the next page for opening the two tabs.

Once you have selected the 2 tabs that you require to be tiled, you can then right click, and you will be shown a popup menu as seen above !!!!

If you then select, the tile 2 tabs option from the drop down menu, the screen will look as follows:-

From the above screen shot, you can now refer to both of the documents without getting confused !!!! Please note, you can use this method to tile 2, 3, 4, Etc.

- * NET Framework 4.0 or higher (if running on Windows) and a spare USB 2.0 port.
- * Microsoft Edge WebBrowser & Microsost Media Player.

Please note, that LeagueLoch's printing subroutines, will need to use your hard drive as a data buffer and will write temporary files to your hard disk/directory 'c:\temp'.

The DVD/RW or USB, should automatically run. It should load and run a file called **DisclaimerAndLoader.exe.**

If this disclaimer program does not run.

Please manually run this file as it is needed to show you the disclaimer screen, as you must read it and agree with it; before you can start using any of my data !!!! (Please also note, that running the disclaimer program and agreeing to it, will also enable any in document links to function. This will includes all word doc's, pdf's and html files.)

The disclaimer/loader program with map the USB-stick to drive letter R:\ (All the in document links are linked to drive R:\) You can manually map the USB-stick as the R:\ drive, by using the COMMAND LINE, command:-SUBST [R: [usd-drive:]path]

By using the following command, file: within the records summary text box, it will enable the user the ability to link to other reference documents held on other drives etc. For example, file:r:\clients\Rv \New_Evidence\New_Evidence_For_Appeal.doc (r:\ = (your drive), Rv = (directory), New_Evidence = (directory) and New_Evidence_For_Appeal.doc = (document)) You can also use an additional parameter for pdf files. It will force a jump to a desired page. (For an example – example.pdf#page=2) This will force the pdf viewer to jump to page number 2. (Please ensure that the parameter is in lowercase.)

Other commands that the user can use within the record summary are.

The mailto: command.

This command it's self explanatory. For example, if you just type mailto:john@example.com, within LeagueLoch's record summary it will automatically place a email link.

To adding a website link, just type in the website's url, excluding the http:// part. For example, www.example.com

LeagueLoch's has a built in spelling checker. When you are typing in the Case Notes/Summary field, it will automatically check your spelling !!!! Any miss pelt words, will be highlighted with a red squiggly line and to correct the spelling you just simply right click and select a word from the list!!!! Please note that 99% of all the HTML files held of this USB were created using the LeagueLoch's, create HTML file option (page20) and then edited using a word processor !!!!

Please also note, that all PDF files were individually scanned, and individually edited with a word processor !!!!

You are also authorised to re-distribute the RunMe_First.exe, file.

(Please also, re-distribute the files, cleanup.bat, and mappingdrive.bat; with RunMe_First.exe)
